Not Sure About The Covid (SARS-CoV-2) Vaccination?

Here's one option. January 14, 2021, the National Institutes of Health (NIH) released their update on considering adding **Ivermectin** to their Covid-19 protocols. (Yes cattlemen, that same Ivermectin.) They say more studies are needed but based on the first review **the NIH no longer opposes its use for Covid**. After all, the discoverer of Ivermectin in 1975 was awarded the 2015 Nobel Prize in Medicine, given its global impact in reducing onchocerciasis (river blindness), lymphatic filiariasis, and scabies in endemic areas of central Africa, Latin America, India and Southeast Asia. It has since been included on the WHO's List of Essential Medicines with now over 4 billion doses administered. The NIH's recent report said,

Reports from in vitro (I.e test tubes) studies suggest that ivermectin acts by inhibiting the host importin alfa/beta-1 nuclear transport proteins, which are part of a key intracellular transport process that viruses hijack to enhance infection by suppressing the host antiviral response. In addition, ivermectin docking in vitro may interfere with the attachment of the severe acute respiratory syndrome coronavirus 2 (SARS-CoV-2) spike protein to the human cell membrane....Ivermectin has been shown to inhibit the replication of SARS-CoV-2 in cell culture....Ivermectin demonstrates potential anti-inflammatory properties in some in vitro studies, properties which have been postulated to be beneficial in the treatment of COVID-19.
