Dear Chief Thum,

May 4, 2023

In the coming days I would like to arrange an appointment with you, a city attorney and any other party under your command that you wish to be present or whom you'd like to delegate to serve in your absence.

I am organizing a group of Christian men, mostly Boomer generation men (62 to 80 years of age) but not all, who are coming to the Sioux Falls Pride parade June 10, with large signs to walk along the public sidewalk and publicly repent to the younger generations for not stopping the sexual revolution back when they were children. Here is a sample of some of the artwork of the signs we plan to carry.



We are going to walk on the public sidewalks only because I was turned down twice, at my request of **Sioux Falls Pride** to pay for and secure a float entry in their parade. In addition to asking their generation's forgiveness for our past cowardice and apathy (back when they were children) we also wanted to use our float entry to evangelize them with the Gospel of Jesus Christ and what the Law of God requires in human sexual relations. We would have preferred that, but I fear they were

motivated by their ignorance of Biblical Christianity, and they may be a bit prejudice against us. Maybe a bit bigoted, too?

Please have your Intel people pull out their files on me from back in the Chief Leroy Campbell era – this would be a generation before you first went to work for the city. I led street protests and nonviolent civil disobedience against Sioux Falls abortionist Dr. Buck Williams, 30 +/- years ago. Nonviolence was our hallmark during those tumultuous years of my leading nearly 100 people to confront the violence of abortion. These included many Protestant pastors, then-Catholic Bishop Paul Dudley and several Catholic priests who were all arrested and jailed. In one case the late Jeremiah Murphy, Esq. successfully represented me in Minnehaha Circuit Court.

You might also check with the FBI to inquire about their file on me **MP 266A-MP-41492**. I have a copy, but it has some redactions. The file and allegations are full of the delusions and lies from the Sioux Falls' Queen of her Christian sex empire, Leslee Unruh (Alpha Center). You see, I operate under this 'funny' notion that the only way Christian children can be taught about sex is by the authority of Christ, His Word, their parents, and Godly preaching from the pulpit. When they fail at this, we should call them to repentance but not provide a humanist substitution as Unruh does. My wife and I raised eleven children this way and we're confident that the eight (so far) who are married were married as virgins. Our 35<sup>th</sup> grandchild (so far) is on the way.

Unruh believed nearly thirty years ago she (and her staff) should be hired to stand in front of pubescent children and talk to them about "Intercourse that involves any other opening than the vagina involves great risk...." (and a host of other filth) or else sell schools the curriculum that teach this. She also believes that when she has knowledge that a Christian girl plans to go through with her abortion, they have a duty NOT to call her parents or pastor. And <u>due to my public objections to all this as violations of God's Law, back then, she made bold deceitful statements about me that captured the attention of the FBI, which led to their investigation. The FBI first wanted to conduct an interview of me and later just dropped the entire matter without the interview. Apparently, they figured out she was a fraud. Only years later did I learn that it is a criminal offense to lie to federal investigators.</u>

Also, you might give Sioux City, IA Chief of Police Rex Mueller a call and ask him about our conduct two years ago when I led seven men (including a former NW Iowa County Attorney) to picket a **Reid Institute** training class he was sponsoring, that teaches police officers how to lie. I have a long history of non-violence to persons and property, with one exception. In October of 2018 I did check out \$75 worth of transgender public library children's books from the Orange City, Iowa public library and ended up burning them across the street from a Drag Queen festival. They were later paid for, and I received a misdemeanor conviction with a fine and court costs of \$125. See news account <u>here</u>.

## But who is gearing up to use violence? That is what I'm writing to you about today.

As you said to a local media outlet, <u>here</u>, "There's more guns out there. There's more people willing to use them. And that's just a societal issue that we kind of need to talk about....and we need to talk to, especially young people about guns."

Regarding young people and guns, I am sure you are aware that a transgender terrorist went into a Covenant Christian school in Nashville, TN March 27, 2023, and murdered three children and three adults with her rifle, before being shot and killed by Nashville police. I am Reformed/ Presbyterian and have friends who know people from that Presbyterian Church. She had a Manifesto, but the FBI interjected and obstructed its release. (I imagine they are threatening to pull federal funds to the city or some such other financial threat.) But thankfully, the **National Police Association** is suing the city of Nashville to recover a copy of her Manifesto. See <u>here</u>.

I am deeply alarmed that she may be calling for more 'suicidal' trans girls to murder Christians who

adhere to Biblical sexual morality. This Manifesto needs to be seen! I am greatly alarmed by the criminal conduct of teachers, parents and medical personnel who are giving puberty blockers to naturally emotional girls, then loading them up with testosterone, while cutting off some of their youthful breasts. One can only imagine how suicidal many of them become when they realize their future lives have been destroyed by these adults. So, any suicide desire of theirs needs to get 'channeled' to those who did this to them or to those who say it was morally wrong. I imagine it's easy for the criminal parents and other adults to divert it toward we Christians, so it won't blow back on them.



Watch this <u>deeply disturbing video</u> of a 'trans' terrorist born with XY chromosomes promote gun violence against Christians objecting to any 'trans' attempting to enter a woman's bathroom. Somehow, I doubt they will limit their use of firearms to the entrance to women's bathrooms only. I am also concerned that Sioux Falls Mayor Paul TenHaken has been signing <u>public proclamations</u> the last few years for Sioux Falls Pride "honoring the history and achievements of the Transgender." I wonder if this is going to encourage them to 'up the ante' while enjoying the mayor's support. It certainly is irresponsible for Mr. TenHaken to sign such a

public statement without considering the mindset of those he's honoring.

I certainly hope this is not new information for your Intel personnel.

**Also,** in 2019 at the very first Sioux Falls Pride parade my son-in-law and some of his Christian friends preaching on the sidewalks during the parade observed naked males on the parade route. They called to a city police officer and pointed it out and asked him to enforce the public decency laws. The officer gathered some other officers and formed a 'human wall' to block the Christian men's visibility of the naked men, while doing nothing to those homosexuals breaking the law.

This leads to a part of the agenda of the meeting we'd like to have with you. I would like to discuss these matters with you in the context of our efforts to de-escalate any confrontation a trans terrorist or other sexual miscreant may initiate; also, in the context of South Dakota **Code 22-18-4.1 Defense of person** and **Code section 22-24-1.2 and other statutes on Public Indecency and others.** 

After review of above, could you get back to me and let me know what would work in your schedule for a meeting. I will do whatever I can to accommodate your schedule.
